

MOTION FOR RECONSIDERATION

On September 30, 2014, Relator, Charles Chandler Davis, SBN 05465900 filed a Petition for relief with the Board of Disciplinary Appeals and amended same seeking relief from an evidentiary panel proceeding, arising in the 14th Grievance Committee Administrative District . At the time a record had not been prepared, of the subject hearing conducted by the Honorable Chairman William Altman, styled the *Commission for Lawyer Discipline v. Charles Chandler Davis*, and numbered Cause No. A0051113770, on September 26, 2014.

On October 1, 2014 Relator filed a Motion for Expedited Consideration, on October 2, 2014, a Request for Temporary Relief and on October 6, 2014, a Motion for Emergency Relief. The Commission for Lawyer Discipline filed its Response to Relator's Request for Temporary Relief on October 3, 2014. A request was made for hearing with the Clerk of this Honorable Board for October 22, 2014, and a temporary stay was requested.

On October 7, 2014 after reviewing the Petition and the motions as well as the response of the Commission for Lawyer Discipline this Honorable Board denied the motions listed as well as the motion in Case No. 55039. A separate request for


reconsideration in that separate matter is being prepared for filing. Relator respectfully requests reconsideration, and review of the portion of the record prior to presentation of evidence on September 26, 2014.

Relator, was able to secure a portion of the official record and tenders same to this Honorable Board as required by Texas Rules of Civil Evidence, Rule 201(d), respectfully we request a separate written order regarding such judicial notice, raised for the first time involving the partial record tendered .

On October 7, 2014, this Honorable Board denied the Petition for Writ of Mandamus, Motion for Expedited Consideration, Request for Temporary Relief and Motion for Emergency Relief. This timely request for reconsideration of such ruling is not filed for purposes of delay, but to insure that justice is done.

In support of this request for reconsideration a brief is being prepared, a copy of which will be provided to all counsel and this Honorable Board on the 10th of October 2014.


