AGREED JUDGMENT OF PUBLIC REPRIMAND

On this day the above-styled and numbered reciprocal disciplinary action was called for hearing before the Board of Disciplinary Appeals. Petitioner appeared by attorney and Respondent appeared in person as indicated by their respective signatures below and announced that they agree to the findings of fact, conclusions of law, and orders set forth below solely for the purposes of this proceeding which has not been fully adjudicated. Respondent waives any and all defenses that could be asserted under Rule 9.04 of the Texas Rules of Disciplinary Procedure. The Board of Disciplinary Appeals, having reviewed the file and in consideration of the agreement of the parties, is of the opinion that Petitioner is entitled to entry of the following findings, conclusions, and orders:

Findings of Fact. The Board of Disciplinary Appeals finds that:

- (1) Respondent, Michal L. Hebert, Bar Card number 09364300, is an attorney licensed and authorized by the Supreme Court of Texas to practice law in the State of Texas.
- (2) On or about October 4, 2022, an Order Per Curium was entered by the Supreme Court of Louisiana styled Supreme Court of Louisiana, No. 2022-B-1222, In Re: Michael L. Hebert, Attorney Disciplinary Proceeding, which states in pertinent part:

The Office of Disciplinary Counsel ("ODC") commenced an investigation into allegations that respondent failed to timely remit funds to a third-party medical provider in violation of Rule 1.15(d) of the Rules of Professional Conduct. Prior to the filing of formal charges, respondent and

ODC submitted a joint petition for consent discipline. Having reviewed the petition,

IT IS ORDERED that the Petition for Consent Discipline be accepted and that Michael L. Hebert, Louisiana Bar Roll number 18253, be publicly reprimanded.

- (3) Respondent, Michael L. Hebert, is the same person as the Michael L. Hebert who is the subject of the Supreme Court of Louisiana Order Per Curium; and
- (4) The public reprimand entered by the Supreme Court of Louisiana is final.

Conclusions of Law. Based upon the foregoing findings of facts the Board of Disciplinary

Appeals makes the following conclusions of law:

- (1) This Board has jurisdiction to hear and determine this matter. TEX. RULES DISCIPLINARY P. R. 7.08(H).
- (2) Reciprocal discipline identical, to the extent practicable, to that imposed by the Supreme Court of Louisiana is warranted in this case.
- It is, accordingly, ORDERED, ADJUDGED, AND DECREED that Respondent,

Michael L. Hebert, State Bar Card No. 09364300, is hereby PUBLICLY REPRIMANDED as an

attorney at law in the State of Texas.
