(2) Respondent's undersigned lawyer was retained on 19 September, 2023 to represent him in this matter.



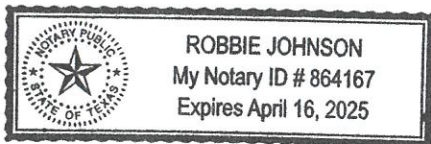
